The committee realizes that all Club members need to be brought up to date as best as possible to be aware of the consequences of re registering or not.

Jenny Hobbs has offered the club help in this regard. Jenny has put forward the suggestion that we use the services of Christa George from SocialLink in Tauranga, they are funded by the Councils of the BOP to provide free support for community groups and organizations.

It is suggested that a sub committee be put together to work on this important matter. As you can imagine the Act document is huge and simply cannot be reproduced, however there are a number of Email addresses in the attached documents for those of you who wish to investigate further.
